## Rules & Regulations of the Texas Hunters Expo

1. **Security:**

Lessor will provide Private and Local (P.D.) Security at all Expos. Security personnel will be under the direction of our in house Director of Security. Security will patrol the premises during and after Expo hours, however, Exhibitors need to provide their own booth security during Exhibition show hours. IN NO EVENT does Lessor assume liability for loss or damage by any cause.

2. **Liability**

Neither Texas Hunters/Sportsman's Expo, the management, employees, nor those acting for them shall be liable for any injury to person or property from any cause; and the exhibitor on whose leased space or through whose fault or neglect said injury shall have occurred shall indemnify and hold the lessor HARMLESS AGAINST ANY CLAIM ARISING OUT OF SUCH INJURY.

3. **Insurance:**

It is required by the lessor that the exhibitor protect himself fully with regard to any property loss through fire, theft or physical damage as a result of this exhibit. The lessor assumes no responsibility whatsoever in connection with such losses or in connection with injury to the employees of the exhibitor.

4. **Weather/Attack/Pandemic/Natural Disaster:**

If the expo has to be postponed (to a later date in 2022) or canceled (and pushed to 2023) due to bad weather (hurricane), natural disaster, global pandemic or terrorist attack, all payments will be transferred to new date of the event or to 2022's event.  
**NO REFUNDS WILL BE GIVEN. ALL PAYMENTS WILL CARRY OVER.**

5. **Payments:**

In the event payments are not received according to contract terms, Texas Hunters Expo reserves the right to cancel contract and all payments made to date are non-refundable.  
ANY BOOTH NOT PAID IN FULL BY 5/1/21 WILL BE SUBJECT TO BEING MOVED/SOLD

6. **Late Fee:**

Exhibitor acknowledges their responsibility in ensuring payment according to the terms agreed upon. In the event payment is not received by the due date, the agreement is subject to a \$50.00 re-booking fee.

7. **Floor Plan:**

Texas Hunters Expo reserves the right to adjust or make changes in booth assignments up to and including the date of move in, to ensure an even flow of Traffic or to maintain the theme of the Hunters Expo.

8. **Fund Raising & Raffles:**

Fund raising activities and or raffles are strictly prohibited unless prior written consent is obtained from Texas Hunters Expo. All drawings for prizes and or giveaways must be completed by 4:00 PM Sunday (or last day of Expo).  
**NO GUN RAFFLES ARE ALLOWED UNLESS APPROVED BY THE TEXAS HUNTERS/SPORTSMAN'S EXPO!!**

9. **Food & Beverage:**

No food or beverage may be sold at the Expo. Under certain conditions, the sale of Dried Jerky, Smoked Meats and Roasted Nuts may be approved through the Show Concessionaire. It is the responsibility of the Exhibitor to obtain written permission (45) days in advance of show date(s). All Food Permits, Concessionaire Fees, and or necessary documentation is the responsibility of the exhibitor, and under no circumstances will the exhibitor receive a refund for failure to comply, and or obtain the necessary documentation.

10. **Cancellation of Contract:**

THE **TEXAS HUNTERS & SPORTSMAN'S EXPO** RESERVES THE RIGHT TO BREAK OR CANCEL THIS CONTRACT UP TO 45 DAYS PRIOR TO SHOW DATES DUE TO ANY AND ALL REASONS WE FEEL/DEEM NECESSARY. ANY VOIDED CONTRACT WILL RECEIVE A 100% REFUND. IF **A VENDOR** DECIDES TO CANCEL THEIR CONTRACT, NO REFUNDS WILL BE ISSUED. YOU WILL GET A CREDIT FOR THE FOLLOWING YEAR IF YOU CANCEL 45 DAYS PRIOR TO THE EXPO. ANY VENDOR CANCELLATION DONE WITHIN 45 DAYS WILL NOT RECEIVE ANY CREDIT FOR THE FOLLOWING YEAR.
